SPECIFICATIONS ON ANNUAL REPORT AWF 2019

LOAN HULSMAN FAMILY

This is a loan of nominal € 106.000, of which remained 64.107 at the end of 2019. This loan is only to be used for buying a house in The Hague, Holland. On December 23, 2016 the ownership of the house was taken over by the children of Mr. and Mrs. Hulsman, and the loan is also taken over by them and is continued with an interest charge of 2,5% per year, fixed. The loan has to be repaid before June 4, 2040. Earlier payments are allowed.

LIABILITIES / LOANS

This is a loan of nominal € 76.000 received from Mr. Raga'ie Khalil, only to be used as a loan to the Hulsman family to buy a house in The Hague, Holland. Agreed is that this loan will be for a period of maximum 30 years from 2011. Interest charge 1% per year, fixed. Earlier repayments are allowed. In 2015 an amount of € 26.000 is repaid so the balance on December 31, 2019 was € 50.000. The reason why AWF is giving a loan to the Hulsman family is that it was impossible for them to get a loan from the Dutch banks because of their uncertain income. AWF feels it as her responsibility to help the directors of CIDT. We were happy that we could fund this loan by a loan from Mr. Khalil.

RESERVATION TAX CLAIM OLD CIDT

The amount to be paid to the Egyptian Tax and auditors for the tax claim of Old CIDT was a total of € 32.360, of which an amount of € 25.339 is paid until May 2018. The remaining amount is still in discussion on the date of this report. From the contributions that AWF received, from Kerk in Actie € 15.000 and from others € 17.235, an amount of € 5.000 was paid to CIDT in 2014 and € 12.026 was settled in 2016 by Mr. Hulsman through his current account with AWF. From the remaining € 15.209 an amount of € 9.000 was paid in May 2018, the rest of this amount will be paid after the tax claim becomes final. When the final claim will be lower the remaining money will be added to the reservation for the pension of S. Gabra.

RESERVATION PENSION S. GABRA

Mrs. Sawsan Gabra is chair of CIDT in Egypt. She lived for a long time in Egypt and for that reason she has an AOW gap of 42% and no other pension in The Netherlands. As she lives in the Netherlands again the AWF has decided to support her by building up a pension reserve, to be paid out from the age of 65. There has not been made a pension-agreement. Her husband, Cornelis Hulsman, also has an AOW gap of 28% following 15 years living and working in Egypt. His pension from the seven years he worked in the Dutch emigration service is extremely small. The AWF, therefore, sees this support for their pension as its social responsibility to a couple that has dedicated so much of their life to the cause of AWF.

CURRENT ACCOUNT ASAH

From the Stichting Free Press Unlimited we received an amount of € 80.536,80 which is labelled to be used only for the Sawt al Hurr foundation in Egypt (ASAH). The remaining amount of € 15.105 per December 31, 2018 was fully spent in 2019.

EXPECTED LOSS FOR CIDT, EGYPT AFTER 2019

MISEREOR decided not to continue funding CIDT in Egypt after 1.7.2019. For this reason the donations of the Christian Reformed Church (CGK) will be used to help cover the shortage of CIDT that then is expected.
